

## 歐盟文教系列報導之九一

### 歐盟文教總署 2 項教育計畫公開招標

歐盟文教總署“歐洲經濟教育專家網絡”及“大學與產業合作評鑑研究計畫”公開招標，預定九月截止。

“歐洲經濟教育專家網絡”(European expert network on economics of education, EENEE)計畫，其背景為 2010 年制訂的「歐盟 2020 策略(European 2020 strategy)」，將人才教育培訓列為歐洲經濟與社會發展的重要主題；然而近期的經濟蕭條與歐洲債信危機，在歐盟各國財政緊縮下，如何有效的運用經費，並發揮最大效益，成了新的課題。歐盟執委會成立 EENEE 的目的就在組成一專家網絡，以經濟學觀點，檢視各項教育及培訓措施。

該網絡需至少包含 8 名學者專家，1 名行政協調人，1 名科技協調人，且成員必須兼顧歐盟地區及性別的平衡，歐盟地區以外之學者專家，亦可納入成員。主要工作有三：提供歐盟執委會每年於制訂重大教育政策前端之分析及建議，估計每年約 20 個主題；蒐集並分析與經濟教育有關之議題，並撰寫報告，提供會員國作政策時之參考，平均一年約 6 篇；架構 EENEE 網站。

標案自即日起至 9 月 3 日受理，歐盟執委會編列 15 萬歐元經費，計畫期間原則自 2012 年 12 月 20 日起 1 年。

“大學與產業合作評鑑研究計畫(Measuring the impact of University-Business Cooperation)”則為歐盟文教總署另一項重要計畫。

「歐盟 2020 策略(European 2020 strategy)」將教育投資視為歐洲未來發展的重要因素，而高等教育尤為關鍵。然而近年來歐洲高等教育卻出現與產業脫節的現

象，學術、研究界的研發成果，無法移轉應用於產業界，進而發展為新產品、服務，市場、工作機會，落實知識經濟。

2011 年歐盟成立一知識聯盟(Knowledge Alliance)，目的在建立一個高等教育與產業部門合作夥伴關係的平臺，以補強這項缺失。目前平臺業已被列為 2014-2020 年伊拉斯莫斯整體計畫(Erasmus for all)的重要核心方案。因此強化及深化高等教育與產業實質合作，將為歐盟教育重要走向。

本研究計畫主要工作為蒐集並分析歐洲現有的學校產業合作現況、效益，並進而發展出一套”知識經濟”質與量的評估標準。計畫成員需至少包含 5 名學者專家，研究範圍必須至少含括 9 個歐洲國家，不同型態的高等教育機構、公部門、公益團體等；計畫期限為一年，依照歐盟執委會規定訪視、召集會議研商後，擇定至少 10 個具代表性的個案作分析標的。

本項計畫自即日起至 9 月 13 日公開招標，預算金額為 20 萬歐元，計畫自 2012 年 11 月 1 日起為期 1 年。

## Open call for tender EAC/23/2012 – Measuring the impact of University- Business Cooperation

**Deadline: 13 September  
2012**

The European Commission has decided to launch a study on the outcomes and impact of cooperation between the higher education sector (hereafter referred to as universities or higher education institutions (HEIs) and the business sector (referred to as enterprises, companies or business). The study should explore university-business cooperation with a particular focus on new areas of cooperation beyond the domain of research & development (R&D). It should address university-business cooperation in non-R&D related areas and focus on the educational and business aspects and motivations, e.g. joint skills strategies, lifelong learning, curriculum design and delivery, entrepreneurial initiatives, business driven alliances, etc.
